The Atlanta Bar-B-Q Club is proud to announce the 8<sup>th</sup> Annual Atlanta BBQ Festival at Perimeter Mall in Atlanta, Georgia on August 12<sup>th</sup> and 13<sup>th</sup>, 2016. Join us as we fire up the grills and celebrate great BAR-B-Q! The 2016 Atlanta BAR-B-Q Festival will offer up cooking competitions, entertainment and activities on Friday, August 12<sup>th</sup> from 4pm – 10 pm and Saturday, August 13<sup>th</sup> from 12 noon – 8pm. We are anticipating an attendance of more than 13,000 at this year's event.

The Atlanta BAR-B-Q Festival is the only BAR-B-Q competition in Atlanta's city limits and is held at the special event area of Perimeter Mall (4400 Ashford Dunwoody Rd, Atlanta, GA 30346). The event's extensive marketing campaign includes all media formats (television, radio, print, online, outdoor media, direct email/mail) as well as a public relations campaign covering the local and regional area.

Participating competitive BBQ teams will be eligible to win more than \$13,000 in cash prizes and trophies. Friday all teams are invited to compete in our "Anything Butt" contest featuring a simple meat (i.e. salmon, steak, etc.) with meat provided by a sponsor. Saturday, Teams will compete in various individual categories with a Grand Champion selected.
